

TRIBUTE TO DISTRICT 11-E1'S OUTSTANDING LION KARLA ROEBUCK Karla Roebuck passed to the Lord on December 30, 2020. She was one of District 11-E1's most active, outstanding Lion. Karla was always there to help and contributed many hours to Lionism on a local and District level. She will be missed.

Karla joined the Chippewa Lake Lions Club in 2004, the same year she was elected Club President. She served as Club President until 2009. She served as Club Secretary for 12 years from 2009-2020. Karla was the Club's Webmaster and combined that position with other publicity and marketing duties. She was active in the merger process when the Chippewa Lake Club merged with Mecosta in 2014 to become the Chippewa Lake-Mecosta Lions Club, Karla took over the task of scheduling the dozens of volunteers needed for the Food Wagon. She served as the Club's Marketing and Communications Chair. Karla served as a club officer and learned about Lionism by attending and participating in Zone meetings, Cabinet meetings, the Lions Leadership Institute, and District 11-E1 conventions every year since 2005. At that time, she was appointed to the District Information Technology Committee and served as Committee Chair and District Webmaster since 2008 when she was tasked with completely rebuilding the District Website. She also served on the District 11-E1 Publications Advisory Committee, District Social Media Chair, and as the District Public Relations and Lions Information Committee Chair, which led to State involvement on those committees. She served the District as a Zone Chair and Region Chair. Karla participated in computer training sessions at State Conventions as well as the Michigan Forum over the years and ran a computer lab with her team of trainers at every District 11-E1 Convention since 2006. She was a trainer for Secretaries at District Officer Trainings offered across the district since 2015. Since 2017, she prepared the program for the Memorial Service at District Conventions. Karla served as State chair of the Information Technology Committee. She assisted the District 11-E1 Defense Against Diabetes grant administrator with computer work on brochures, business cards, and the DAD pin and then was selected as the State of Michigan Defense Against Diabetes Grant webmaster for the 2019/2020 grant duration. Awards and honors have been many and each honor touched Karla's heart and solidifies her resolve to continue to "Serve" in any way she could. The honors include various District Governor appreciation awards, International President Leadership award, International President Certificate of Appreciation, Membership and sponsorship awards, and the International President's New Voices award for Marketing. She was awarded the Ken Lautzenheiser Fellowship award twice. In 2010 at the State Convention on Mackinac Island, Karla was presented with a Mother Teresa Humanitarian Award.

Karla retired from being an Associate Broker at Greenridge Realty Oakmont in Big Rapids, MI. She and her husband Lion Bob had 3 grown sons who all grew up with a spirit of volunteerism. They have served as trainers on the District IT Committee, and all joined the Lions Club. Randal and Tyler are computer techs and Jared is in Mechanical Engineering. Jared has attended almost all District Conventions since he was 5 years old, went to Spain with the Lions Youth Exchange program and joined the Chippewa Lake-Mecosta Lions club on his 18th birthday. 


First Vice District Governor Bill Bradfield


Lions of Michigan Foundation

Rochester Hills, Mich., October 28, 2020 - Leader Dogs for the Blind, located in Southeast Michigan since 1939, announced today that they are launching a free virtual seminar for people who are 18 - 24 years old, legally blind or visually impaired, and from the U.S. and Canada. T.O.M. Talks focuses on three areas of importance for people who are blind: Technology, Orientation and Mobility. The seminar is free and will be held January 17-30, 2021. Participants will develop skills needed to thrive in their career including increased independent travel, professional readiness and networking. A variety of experts from Leader Dogs for the Blind will present including guide dog mobility instructors and orientation & mobility specialists. "People in the 18-24

age groups tend to have very busy schedules," said Erica Ihrke, Leader Dog's manager of extended services, "so we designed this program to be partially self-guided and partially live. Our goal is for everyone to be able to achieve success." There are four required live ZOOM sessions and two optional weekend sessions. The self-guided portion of the curriculum includes videos and activities supported with materials sent prior to the T.O.M. Talks. To apply for T.O.M. Dear Michigan Lion:

On June 28, 2018, Governor Rick Snyder signed Public Act 255, creating a Lions of Michigan Foundation Fund within the Michigan Department of Treasury to assist our foundation in collecting donations to help improve the quality of life of people in our state with unmet needs. Public Act 255 of 2018 added our Lions of Michigan Foundation to the list of only nine Michigan charities eligible to receive donations directly from Michigan tax payers when they file their annual state income tax return.

As each gualified charity is required to collect \$50,000 in donations annually through this special program to guarantee eligibility for the future, we are asking for any help that you can provide to ensure that we remain eligible. Just a donation of \$5 to \$10 to our foundation from each Michigan Lions member or a family member or friend on the Michigan Voluntary Contribution Schedule (MI Form 4642) would ensure that we cannot be removed from the list of gualified charities.

Since 1984, our Lions of Michigan Foundation has operated programs that address serious human needs in our state. By working in partnership with our Michigan Lions Clubs and other community service organizations and charities, we provide disadvantaged Michigan families with access to affordable eye care, hearing aids and services aimed at helping people succeed academically and socially, gain and retain employment, maintain independence and prosper in life. We support our member Lions Clubs and their communities to help make them stronger and more viable.

Our foundation provides funding for equipment, supplies and program expenses for Project KidSight and the resources necessary for our Michigan Lions to help children suffering from vision loss. Through our Emergency Individual Assistance Program, our foundation helps military families and veterans who have emergency needs, and we help people who suffer from severe vision and hearing disorders that can only be corrected through surgical intervention or costly medical procedures. Through our Lions Affordable Hearing Aid Program, our foundation helps low-income people who suffer from hearing loss maintain self-sufficiency. And, through our Emergency Disaster Relief Program, we help families affected by natural disasters, including severe storms, flooding, fires and tornados.

We greatly appreciate any support that you and your family members and friends can provide to assist us in raising the \$50,000 required to remain as one of the charities eligible to receive donations through Michigan income tax return filings. With your help, we can continue to play a significant role in solving the social, economic and health care issues facing our state.

Instructions for Form 4642, Voluntary Contributions Schedule

Michigan taxpayers can contribute \$5, \$10, or more to any of the following funds on the *Voluntary Contributions Schedule* (Form 4642). Contributions to these funds will increase your tax liability or reduce your refund.

American Red Cross Michigan Fund

The American Red Cross is always there for you and your community, helping to alleviate suffering caused by disasters big and small. The Red Cross shelters, and provides emotional support to Michigan residents and beyond; supplies about 40 percent of the nation's blood; teaches skills that save lives; provides international humanitarian aid; and supports military members and their families. By mobilizing the power of volunteers and the generosity of donors, the Red Cross responds to more than 60,000 disasters annually. In Michigan, last year more than 6,000 volunteers logged more than 200,000 hours assisting others. On average 91 cents of every dollar the Red Cross spends is invested in humanitarian services.

Animal Welfare Fund

The outside world can be a harsh, scary place for homeless pets. And throughout Michigan, small towns and big cities alike struggle to find the resources they need to provide medical care to the animals they rescue. Through the Animal Welfare Fund, the Michigan Department of Agriculture and Rural Development (MDARD) offers grants to Michigan's registered animal shelters to help support spaying and neutering programs for shelter dogs and cats up for adoption. Grants also help support many anti-cruelty and proper care programs around the state. Shelters also use grant monies from your generous donations to help care for animals that are seized as part of animal cruelty cases.

Children's Trust Fund - Prevent Child Abuse Michigan

The Children's Trust Fund (CTF) supports services throughout Michigan to prevent child abuse and neglect. CTF funds home visitation services; respite care; services for families with incarcerated family members; and parenting education and support. CTF supports a statewide network of local Child Abuse and Neglect Prevention Councils. Examples of local Council work are teaching professionals about mandated reporting; teaching parents and caregivers about infant head trauma prevention and infant safe sleep practices; and establishing baby pantries to provide diapers, formula, and clothing. In the coming year, CTF and its local Councils will lead statewide efforts to build local responses to the opioid crisis.

Fostering Futures Scholarship Trust Fund

Fostering Futures Scholarship provides scholarships to young adults who have experienced foster care to help them achieve a college education. Approximately 13,500 students are in the Michigan foster care system and many students do not have family support after they age out of the system. Nationally, about 75 percent of students express a desire to attend college, less than 10 percent enroll in college and less than three percent graduate college. Scholarships are awarded via an application process and paid directly to the students' college or university to assist with tuition, fees, room, board, books and supplies.
